### OUR PHILOSOPHY.....

The **CHOR Day Academy** serves students grades 1-12 who have special education needs that can be better met in our program setting. The program is designed to help students bridge educational gaps while working toward completion of required credits for the school year.

Our goal is to provide students with a well-balanced educational and therapeutic program to guide them toward academic success. The education team is comprised of special education teachers, masters level counselor, regular education teachers, and behavioral support staff.

### PROGRAM DETAILS.....

Doors open for students at 7:30 AM and the first class (period) starts at 8:00 AM. Breakfast and lunch is provided. Instruction is in the major subject areas of language arts, mathematics, science, and social studies. Students also receive career counseling, Health and Physical Education, Art, Music, and Technology instruction.

The student's home school district is involved in the Individualized Education Program (IEP) and the evaluation process as part of compliance with federal and state laws. Our staff collaborates with the student's school district to ensure a smooth transition back into the home school.

### REFERRAL PROCESS.....

The home school district is required to submit a complete referral packet, which includes the following:

- ✓ Application for Admission
- ✓ The most recent Individualized Education Program (IEP) and Evaluation Report (ER/RR) – educational transcripts of grades and attendance records
- ✓ 9th-12th grade transcripts and copy of report card
- ✓ Copy of Health Immunizations
- ✓ Copy of Behavioral Reports
- ✓ Copy of Educational Assessments (PSSA and/or Keystones)

A tour/intake interview is held prior to acceptance. The referring school district is notified of the student's acceptance in the CHOR Day Academy after all of the application information is received and reviewed by the school admissions team.
